INVITATION TO TENDER FOR THE PREPARATION OF SITE AND INSTALLATION OF SCANNER

1.0 INVITATION

THE MAURITIUS POST LIMITED (MPL) is pleased to invite you to submit your best quote for the above-mentioned tender.

2.0 BACKGROUND

The Mauritius Post Ltd (MPL) is a private company which took over the activities of the Postal Services Department in 2003 from the government.

The MPL was established for the purpose of providing accessible, affordable and reliable postal services to all customers wherever they reside. It operates a network of 119 Post Offices across the country to accomplish its purpose. As the designated postal operator, the MPL has to inter alia, offer post office letterboxes service, issuance of postage stamps and conveyance of letters.

3.0 SCOPE OF WORK

MRA is planning to install four 20-feet metal containers that will occupy 84 square metres at the rear of Port Mathurin post office in Rodrigues. Clearance and preparation of site is under the responsibility of MPL.

The scope of work for this project will include the following:

a) Site Clearance

- Cutting down of trees and carting away/ cleaning.
- Removal of existing water tank and re-installation of same including piping and provision with an automatic water pump (1 HP – Silent) including electrical power supply.
- Cleaning of existing water tank. Disconnection, transfer of water tank and reconnection to be done on weekend or after office hours. Water supply to be available upon opening of post office on the next day.
- Demolition of concrete wall and carting away of debris.
- New septic tank and cancelling of existing one including excavation works.
- Disconnection/ reconnection to septic tank to be done on weekend. Washroom and toilet should be operable upon opening of post office.

b) Fencing

• Rebuilding or repairing the damaged fencing surrounding the site with barbed wire on top (Height 180 cm including straining wire).

c) Garage Improvements

Levelling the garage ceiling, which will include:

- Installing appropriate concrete beam 200mm x 400 mm.
- Refitting existing iron sheets to the ceiling.
- Installing a roller shutter to replace the existing metal door for enhanced security.
- A manual device for opening and closing of the roller shutter.

d) Access Modification

- Demolition of the garage wall (located within the back office) to ensure better access for bulk parcels to the scanning room (Replastering where needed).
- Ensuring all access ways from the containers to the post office corridor are securely covered with metal sheets and a metal door at entrance of corridor.

e) Foundation Requirements

• As the installation will include a 3-ton X-ray scanner, site levelling with a concrete structural base of at least 84 square meters is proposed (6 metres x 14 metres). It is to be elevated to the same level of the highest step of the concrete stair found in the garage. The garage floor should remain at the same level.

Note: The foundation works has to be completed within the first 15 days.

f) Land Ownership and Approval

- Verification of MPL's ownership of the land designated for the installation of containers.
- Assessment of necessary authorisations or approvals required by relevant authorities to proceed with this project.

g) Data and Electrical Wiring

 New data & electrical wiring, (camera/ alarm) in container. The location will be provided later.

h) Air Conditioners

• Installation of 4 Wall type ACs, that is one in each container (4 x 18,000 BTU). The location will be provided later.
